

Representative Legal Matters

Commercial / Corporate Disputes

- Representing PRC parties in a shareholder dispute over the shares in a Hong Kong company
 which engages in the mining business in the PRC through various PRC subsidiaries. The
 value of the shares is more than RMB 92 million.
- Representing and advising PRC parties in obtaining interim measures in aid of arbitration in the Switzerland Arbitration Centre.
- Advising and successfully defending for a start-up esports company and its majority shareholders in a shareholder dispute for over HKD 1.4 billion.
- Representing and advising a high net worth individual in family disputes or trust/estate issues in Hong Kong and Macau.
- Representing and defending a listed company and its subsidiaries before the Competition Tribunal for alleged competitive conduct.
